

Why does the 80th CMEF land in Shenzhen?

1. Shenzhen, a new starting point for China's Reform and Opening-up

Shenzhen Special Economic Zone has been steadily walking on the path of socialism with Chinese characteristics and is also the earliest city to grow medical equipment industry. Plenty of independent and innovative products were born in Shenzhen, including China's first magnetic resonance imaging (MRI) system, color ultrasound and automatic biochemistry analyzer. Now Shenzhen has more than 700 medical equipment manufacturers with an industrial output exceeding RMB 40 billion. Standing at the starting line of a new age, Shenzhen will continue to shoulder the responsibility and task to advance the nation's prosperity and strength, revitalize the Chinese nationality and tap into the path for people's happiness.

As the medical service platform for medical equipment in the Asia-Pacific area, CMEF has been deemed the indicator for the industry development for the past 40 years. It has been steering for the industry upgrade and innovating the development mode in building a "healthy China" and undertaken the responsibility and mission to meeting people's increasing demand for a happy life. Meanwhile, Shenzhen has been one of China's most influential industrial clusters for medical equipment where CMEF has been held for many times. The return to Shenzhen for the 80th anniversary marks the fair on the path of a new journey.

2. Shenzhen has offered six measures to support medical equipment industry

Taking advantage of the leading industrial base including electronic information and communications, Shenzhen's medical equipment has spread a benign layout with coordinated BioTech / IT development and is among those regions with largest industrial scale in China. Its annual growth rate for the biological and life health industry has gone beyond 15%, faster than the nation's average. Especially after the 19th CPC National Congress, Shenzhen Health and Family Planning Commission has brought up to construct a pilot zone to accelerate a healthy China in terms of medical and health. In 2020-2025 an international medical center shall take shape and in 2025-2035 a global exemplary healthy city shall be built.

According to Development and Reform Commission of Shenzhen Municipality, six measures will be released to support the city's medical equipment industry development, namely the construction of scientific research institutes including medical schools, mapping for major industrial technology layout, coordinated innovation between industrial, academic and research sectors, completing the industrial facility system including medical equipment examination and assessment, deepening corporate medical services and precise poverty relief in the medical sector.

Besides, as a city with one of the most active economies in the world, Shenzhen has been a prior destination for foreign investment over the years. It is reported that the city's medical equipment industry has basically spread worldwide, the export value of which accounting for 60% of the total industrial value. The export market is rising high. Therefore to unveil the CMEF in Shenzhen should provide a quality platform to promote trade exchange and future cooperated development for medical practitioners at home and abroad.





Exhibitor / Visitor Data




